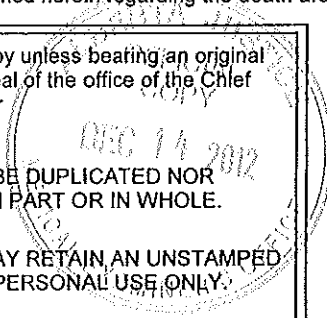

NARRATIVE SUMMARY OF FINDINGS AND CONCLUSIONS RELATED TO DEATH: (Include relevant history, laboratory and anatomical findings)

This 31 year-old male was reportedly found collapsed and unresponsive by his father at their residence. He has clinical history of recent orchiectomy to remove right testicular seminoma and subsequently developed swelling of the lower extremities.

Autopsy shows bilateral pulmonary thromboemboli with severe pulmonary edema and pleural petechiae. There is presence of a neoplastic mass that surrounds the adjacent blood vessels in the lower abdomen and pelvis, narrowing the blood vessels lumen. There is a vascular thrombus formation below (distal to) the neoplastic mass in the inferior vena cava. Other findings are conjunctivae and cutaneous petechiae, cardiac septal hypertrophy and evidence of cardiopulmonary resuscitation.

Toxicology examination is not performed.

In my opinion, Greg Michael Price died as a result of acute pulmonary (thromboemboli) secondary to metastatic testicular carcinoma.
